Gang Murder in Gerstle Park

If anyone from our neighborhood isn't aware of it now, there was a stabbing, murder in the Gerstle Park neighborhood Wednesday May 11th.

The incident began at 4:53 p.m. when police began receiving reports of young men armed with sticks and bats running in the 600 block of B Street near the San Rafael Community Center, followed shortly by more calls of a white sedan chasing a red SUV in the Gerstle Park neighborhood.

Within minutes, a resident on Woods Street called 911 and said an injured man came to her door asking for help and then collapsed in her front yard. Officers arrived to find the victim with a grievous injury from a stab wound. The victim, a 21 year old Corte Madera man, was treated by paramedics and taken to Marin General Hospital where he was pronounced dead. Around the same time, two more bloody victims were dropped off at the emergency room. The two men, age 20 and 21, were treated for minor injuries and released into police custody for questioning. Two additional men who came to the emergency room were also detained for questioning in the case and the ER was locked down for a period time as a precautionary measure.

We all can agree, most Gerstle Park residents were very concerned with reading this news. But, this also should be a wake-up call with regard to gang activity in San Rafael and the Gerstle Park neighborhood.

The GPNA will continue to advise residents to lock their cars and their homes. The GPNA also wants to have its residents be more aware of their surroundings. Keep an eye out for groups of young men either driving around the neighborhood or hanging out in Gerstle Park. If buildings, fences, walls, bathrooms or picnic tables have graffiti-like gang symbols, (often referred to as tagging) please let the police know about this. Often the "tags" will disclose which gang is in a certain area and this information will be helpful to the police.

We need more public involvement in these matters. The police can't help us if we don't report suspicious activity. Also, the GPNA provides instant police reports via emails if you wish to receive them. Contact the GPNA and request to be put on this email list.

Crime Tip Form Added to the City's Police Website

The San Rafael Police Department has added a new feature to its website to allow residents to offer tips about criminal activity. The feature, the "Silent Witness Tip Form," provides an online template for informants to submit suspect descriptions, provide information about crime locations and times, and attach photos and other digital evidence. Tipsters can remain anonymous.

Minor League Baseball Proposed for Albert Park

There is a proposal by Centerfield Partners, a minor league baseball organization, to bring professional baseball to San Rafael and use the ballpark facility at Albert Park. There have been two meetings, April 28th and May 19th held at the Community Center, were open to the public and presented by the City of San Rafael Park & Recreation Commission.

The two public meetings allowed the public to voice their approval or disapproval to the proposal, ask questions and bring up concerns with this proposal. Centerfield Partners was also in attendance to answer any questions.

The proposal is to allow a professional team to play 45 homes games at Albert Park. Centerfield Partners is requesting a 3 year Facility Use Permit, make improvements to the stadium, increase temporary seating, add concessions, restroom facilities and fencing.

During the two meetings there was considerable discussion with regard to concerns from nearby neighbors. Parking, security, field maintenance, rest rooms, noise, lights, local traffic, serving of alcoholic beverages and litter were the main points presented to Park & Rec & Centerfield Partners.

As of May 19th SR Park & Rec approved this proposal to move forward and present their findings to various city departments that will study this proposal and review all of the concerns that were presented to the Park & Rec Commission. The next step would be to take the findings of the city departments and present this to the City Council for their approval. At the time of this publication there is no set schedule or timeline for this process to report.

The GPNA does not favor or reject the idea of baseball at Albert Park, but unanimously voted to have this proposal go through all of the necessary city departments and approval processes that is required of homeowners and businesses alike. The GPNA will continue to follow this story and have more information for the neighborhood as it happens.

A New Housekeeping Ordinance

The City of San Rafael recently adopted the 2009 International Property Maintenance Code, which governs your responsibilities for maintaining your home and property. It is comprehensive, and you should be aware of its provisions. You can get the complete text at the City's Code Enforcement Division. Here are the highlights:

- -- Your home and property must be maintained in a clean, secure and sanitary condition, in accordance with the Code.
- -- Your sidewalk, walkways, stairs and driveways must be clean and repaired.
- -- Your property must be kept free of weeds and plant growth over 6 inches in height, except cultivated flowers and gardens.
- -- All accessory structures such as garages, fences and walls must be structurally sound and in good repair.
- -- Inoperative vehicles must be stored in an enclosed area, and painting vehicles outside of an approved booth is prohibited.
- -- Graffiti is prohibited and it is the responsibility of the property owner to remove it.
- -- Garbage cans must not be stored in the public right of way except on the day of removal, and must be stored on non-service days out of public view or nearest the main structure.

Update on Clean & Sober Living Issue

San Rafael City Councilmen Brockbank and Levine met with GPNA committee members to listen to our concerns about the unregulated homes for recovering alcoholics and drug addicts that have been identified in our neighborhood. There are 10 such facilities in San Rafael, some housing 12 or more temporary residents. Of greatest concern were safety issues of the facilities located in older homes that are not up to today's fire safety codes of say, a bed and breakfast. The transient nature of the residents and the difficulty of knowing such neighbors and the impact of parking, noise and smoking were also discussed. The City Attorney and City Planner will be studying the issue this year perhaps proposing code changes. We understand that both city officials are considering forming a city-wide blue ribbon committee to make recommendations in that regard.
